### SCHOOL/GYMNASIUM TECHNICAL INFORMATION

Please read carefully to ensure all requirements are met. (revised as of April 16, 2015)

ARRIVAL AND SET-UP	
	<ul style="list-style-type: none"><li>✓ The artists will arrive approximately 1 to 1.5 hours prior to the performance to set up. All other activities in the performance area must be curtailed during this time.</li><li>✓ Our Stage Manager will be in touch at least 3-days prior to confirm the arrival time.</li><li>✓ Please assign a staff member or be present yourself to meet the artists, answer any questions they may have and inform them when the audience is seated and the show may begin.</li><li>✓ Please provide parking facilities for one van.</li><li>✓ The company requires the following items for the performance:<ul style="list-style-type: none"><li>• 1 table</li><li>• 1 chairs</li><li>• 2 extension cords</li><li>• 1 dust/dry mop</li><li>• Drinking water for four people</li></ul></li></ul>
FACILITIES	
	<ul style="list-style-type: none"><li>✓ The minimum performance space required is 30' x 30' x 12' high. Please ensure that the floor and area being used is clear and free for the set up, performance time and for the take down time on the day of the performance.</li><li>✓ <i>A stage or a gym floor</i> would be suitable for the performance.</li><li>✓ N.B. Dancers, like athletes, are subject to muscular injuries due to temperature change. As a result, the dancers cannot perform if the temperature in the performance and dressing room areas goes below 23°C (74°F). Please ensure that the thermostat is turned up in sufficient time to heat these areas before the dancers arrive.</li><li>✓ Please ensure that the performance area has just been cleaned and is dry prior to arrival and set up. The availability of water, coffee or tea would be appreciated.</li><li>✓ Two change rooms are needed with easy access to the washrooms and performing area with no public access.</li><li>✓ Please have bells, PA systems and air conditioning fans turned off during the performance and discussion period. Please discourage staff and students from entering or leaving the performance area during the show.</li><li>✓ Due to union and copyright regulations, the taking of photos, audio or video recording is strictly prohibited unless permission is received in advance from the company.</li></ul>



<b>SEATING</b>	
	The audience should be seated facing the performance on the floor. The audience size should not exceed 300 students.
<b>PERFORMANCE LENGTH</b>	
	The performance is 45 minutes in length followed by a 5 to 10-minute question and answer (Q & A) session if desired.
<b>AFTER THE SHOW</b>	
	Please allow for 60 minutes for the performers to strike and load out the show.
